This brief newsletter is intended to share important community updates and provide a reminder for our upcoming Holiday Events.

The 2024 Annual Members Meeting was held on December 10th, 2024, and led by Dori Farnihill, part owner of Davenport Property Management. The meeting was called to order at 7:35 PM. Jose Ruiz resigned from the board at the commencement of the meeting due to his demanding new schedule. Thank you Jose for your service on the board and continuing to offer your volunteer services.

Board Election Results:

• Congratulations to our community for achieving a quorum with over 200 votes! Kimberly Reyka and Louis Schilling were elected to the Board of Directors. The crowd applauded and was very pleased with the election results, creating a positive and supportive atmosphere.

Board Reorganization:

- The Organizational Meeting was called to order by President Doreen Levy at 8:11 PM. A quorum was established with all five board members present. The current Board members and their positions are:
 - o President: Doreen Levy
 - Vice President: Andrew Plevin
 - o Treasurer: Maureen Walsh
 - Secretary: Kimberly Reyka
 - o Director: Louis Schilling
 - All nominations carried unanimously (5-0).
- During the meeting, Kimberly Reyka resigned from the Fining Committee, and the positive mood encouraged several members to come forward as volunteers to fill the vacancies on the Fining Committee. The Board expressed gratitude for the community's support and engagement.
- The Organizational Meeting was adjourned at 8:47 PM.
- 2025 Budget Approved:
- The 2025 budget was unofficially approved, setting HOA assessments at \$230/month for all homes/lots not in Carmel and \$275/month for Carmel residents, effective February 1, 2025.

The Board would like to have another December meeting to properly approve the budget and will schedule a January meeting to revisit the parking enforcement procedures and provide updates on our road project.
